Agreement

- All deposits are non-refundable. Deposits may be transferred to a friend for the same year, but are not transferable to a future year.
- If a reservation is canceled by Bozeman Hunting Company (BHC), BHC will return any deposit in full
- Stated hunt dates, length, species, methods, price within this agreement are non-negotiable
- BHC agrees to provide adequate food and shelter for the duration of the hunt
- BHC agrees to provide necessary transportation to and from Bozeman airport for any clients arriving by airline
- BHC agrees to maintain any and all outfitting licenses to operate in the state of Montana and to provide licensed guides for the duration of the hunt
- BHC agrees to provide care and transportation of meat and trophies including caping, field dressing, transportation to taxidermist, and transportation to meat processor
- BHC agrees to make a best effort to recover any wounded or downed game
- Client agrees to maintain proper licensing to legally hunt pursued game in the state of Montana
- Client agrees that all gear such as personal equipment, weapon, clothing is to be provided by the client
- Client agrees that meat processing, taxidermy, shipping, transportation, licensing costs, and any service beyond this guided hunt are not included
- Client agrees that a tag is considered filled successfully, and the pursuit of the primary species is over, when a shot is fired and blood is drawn
- Client agrees that although a guide may make suggestions/recommendations, it is up to the client and not the guide when to harvest an animal or attempt a shot
- Client agrees to relinquish any right to sue BHC, any of its workers, agents, or landowners of leased property, for any injury or damage. Client accepts all inherent dangers and risks associated in the pursuit of game including, but not limited to, rugged terrain, inclement conditions, wild animals, and the use of firearms
- Client agrees that inclement weather, road conditions, delayed flights, sickness, or any other reason that would inhibit an on time arrival does not warrant a refund or extension of the trip. BHC strongly recommends purchasing travel/trip insurance
- Client understands that many factors can impact hunting including weather, your ability, preparedness, etc. and that success is not guaranteed.
- For both guides and clients, safety is the primary concern. BHC reserves the right to end a hunt immediately, without refund, for any safety concerns including, but not limited to, the improper handling of a firearm
